Guidance Note:

Home Visit can be conducted due to various reasons. The two reasons identified are 'At risk of Drop-out' and 'irregular'. A 'At risk of Drop-out' is a person who has missed two consecutive sessions. Once the FF identifies (daily attendance) that a participant has missed second session consecutively, she/he will make a Home Visit to identify the reasons for the absence. This Home Visit report will be filled up.

Another reason is the 'irregularity' in sessions identified through Tool 2. This will be identified quarterly. A Home Visit will be made after an "irregular" participant is identified and this Home Visit format will be filled.

Other than attendance issues, there can be many reasons for doing a Home Visit. For any other reasons also, this Home Visit report will be filled out. If after the Home Visit, the participant says that he/she or his/her adolescent girl or boy will not be coming for any more group sessions, that person will be considered a 'Confirmed Drop-out'. At the end of the report, this information will be recorded if a Confirmed drop-out is identified.
